

Readmission Instructions and Information

*Applicants filing during the extended filing period between April 1 and June 1 will have a late enrollment appointment. Class selection and availability may be limited. To ensure timely processing and enrollment opportunities, we strongly recommend all fall readmission applications to be filed before April 1.

INSTRUCTIONS

If you filed paperwork for an approved Leave of Absence, contact your College Office before submitting application.

A \$70 filing fee will be billed to your student account. The fee is nonrefundable and nontransferable. You are responsible for this fee even if you do not return to UCSC.

In order to be considered for readmission, the following materials must be mailed (or submitted in person to the Office of Admissions) to: Admissions – Hahn, UC Santa Cruz, 1156 High St., Santa Cruz, CA 95064, Attention: Readmission.

- ◆ Statement of Legal Residence
Residence information is required of applicants who have been away from UCSC for two or more regular (fall, winter, spring) academic terms. The request to complete this form will appear on your To Do List when your record is activated. Failure to complete the Statement of Legal Residence will result in non-resident classification and tuition assessment. If you have questions or are currently a nonresident student and you wish to reclassify, you must contact the Residence Deputy, Office of the Registrar by email reg_fees@ucsc.edu or phone (831) 459-2709 or (831) 459-2910.

If you were on probation, barred or disqualified from the University, you should contact your college office well before the filing deadlines. You should allow sufficient time for your college to evaluate your case before a readmission decision can be made.

If you have been issued a disciplinary sanction from the University, you should contact the Judicial Affairs Office at (831) 459-4447 to see if you are eligible for readmission.

TRANSCRIPTS

You must send official transcripts to both the Office of the Registrar, Attn: Student Records, **and** to your college office, Attn: Readmission, from all institutions where you were registered during your absence from UCSC. If your transcript will not be available before the beginning of the quarter, be sure to request that it be sent as soon as the grades are recorded. The transcript(s) must be received no later than the end of your first quarter back at UCSC. If you attended another UC campus during your absence, you must submit an official transcript before your readmission application will be reviewed. Failure to submit a transcript may jeopardize your future enrollment.

ADDRESS & NAME CHANGES

You should update all addresses in the portal, my.ucsc.edu. Change of name must be made by petition at the Office of the Registrar.

MEDICAL WITHDRAWALS

If you were granted a medical withdrawal, your physician or therapist must send a [statement](#) to the UCSC Health Center substantiating your ability to return to your academic program. A conditional approval for readmission may be granted by your college, but enrollment may not be finalized without documentation. If you have questions, contact your college.

FINANCIAL AID

If you wish to be considered for financial aid, you must apply each year using the Free Application for Federal Student Aid (FAFSA), even if you received financial aid when you were last enrolled at UCSC. **The priority deadline for all types of grants, loans and work-study funds available to UCSC students is March 2 preceding the academic year you plan to enroll.** Applications are accepted after the deadline; however, aid will be awarded to eligible students based upon the availability of funds. All students will be reviewed for Federal Pell Grant and Direct Student Loan eligibility regardless of availability of other aid funds.

Important note: Your financial aid application (FAFSA) will not be reviewed until you have been approved for readmission by your college. To ensure your FAFSA is received by the Financial Aid and Scholarship Office, submit your name and student ID number to the Financial Aid Office with a note advising them that you are applying for readmission, or you can stop by their office at 201 Hahn Student Services.

READMISSION ENROLLMENT

ENROLLING IN CLASSES:

After you are readmitted and eligible to register, refer to the portal, my.ucsc.edu, for enrollment dates and instructions. REGISTRATION

Plan to pay registration fees by the deadline in the academic calendar, and any other debts to the University before the quarter begins. The payment deadline is in the Academic Calendar at <http://registrar.ucsc.edu/calendar/>. Note that fee payments received after the deadline result in a \$50 late fee. Billing statements are available through the MyUCSC Portal (my.ucsc.edu). Note that prior debts will result in a hold on enrollment and financial aid. HEALTH INSURANCE REQUIREMENT

READMISSION CHECKLIST

To facilitate your return to UCSC, it is recommended that you do the following:

- ✓ Contact your college office if you were not in good standing when you left UCSC.
